jury verdicts when insurance companies refuse to make fair settlement offers. In 2024, he obtained one of the top 100 largest premises liability verdicts in the United States.

- \$2,027,500 jury verdict at trial for a client who sustained injuries to her neck and jaw when a negligent driver struck her vehicle. The last settlement offer by the insurance company was \$40,000.
- \$1,750,000 recovery for clients that sustained neck and back injuries when their vehicle was struck by a truck.
