## REPRESENTATIVE MATTERS

Each matter handled by Sean is dependent upon the unique facts and particular circumstances. An example of successful matters handled by Sean include:

- Successfully represented and resolved a complex relocation matter involving multiple children and post-judgment relationships
- Successful resolution of complex dispute involving unmarried individuals and their joint business venture
- Successful resolution of hundreds of family law disputes involving issues of spousal support, custody, and equitable distribution of personal property and business interests
- On behalf of estate, obtained judgment declaring testamentary trustee position vacant and substituting new trustee to effectuate purposes of trust.
- Obtained injunctive relief against family members engaging in improper and harassing behavior.
- A favorable settlement wherein a testamentary trust was dissolved and the corpus distributed to the income beneficiary and the remaining beneficiaries, despite clear intent by the testator that the trust remain in place throughout the life of the income beneficiary
