### Stefanie Mozgai Assistant Commissioner, New Jersey Department of Health

Stefanie Mozgai is the Assistant Commissioner of Certificate of Need and Licensing at the Department of Health where she maintains oversight and accountability of the licensing process of all state licensed healthcare facilities to ensure access to services and that those services meet the licensing standards. She also oversees the Office of Program Compliance which is responsible for the administration of both State enforcement and Federal penalties issued on behalf of the Centers for Medicare and Medicaid Services.

The Division of Certificate of Need and Licensing also houses the Behavioral Health and Substance Use Disorder Program which licenses and inspects mental health and substance use disorder programs for compliance with the applicable regulations. The nurse aide certification program and the licensed nursing home administrator board are also included within CN&L.

Prior to assuming that role in January of 2022, Stefanie was the Assistant Commissioner of Health Facility Survey and Field Operations and had the responsibility for ensuring compliance with state and federal requirements and the overall management of the survey and certification process for over 2000 licensed and certified health care facilities including hospitals, ambulatory care, and long-term care facilities.

Stefanie spent one year at the Centers for Medicare and Medicaid Services functioning as Director of the Division of Continuing and Acute Care Providers which developed survey policies and protocols for all acute care providers.

- § 8:43E-3.6 Curtailment of admissions

### Reportable Event Requirements

- 8:43 E General Licensure Regulations and Standards Applicable to All Licensed Facilities
  - 8:43E-10.11 Other reporting requirements unrelated to the Patient Safety Act
  - 8:43E-10.11(a) Immediately report all actual and potential criminal acts to police
  - 8:43E-10.11(b)2 The facility must report "immediately," which means within 3 hours after discovery of the event.





# Chapter 43E General Licensure Regulations Reporting Requirements

8:43E-10.11(c)1-5: Examples of reportable events in the nature of physical plant and operational interruptions:

- Loss of heat or air conditioning;
- Loss of significant reduction of water, electrical power or other essential utility;
- Fires, disasters, or accident resulting in injury or death of patients of employees, or in evacuation from any part of the facility;
- Labor stoppage or staffing shortage that requires temporary closure of service;
- Notices of a potential strike that a facility receives from an employee bargaining unit

8:43E-10.11(d)1-4: Examples of reportable events in the nature of potentially criminal acts:

- Any instance of care ordered or provided by someone impersonating a physician, nurse, pharmacist or other licensed health care provider;
- Abduction of a patient of any age;
- Sexual assault on a patient, visitor or employee within or on the grounds of the facility;
- Death or significant injury of a patient, visitor or employee resulting from a physical assault that occurs within or on the grounds of the facility



### How to Report: Reportable Events

- NoviSurvey is the web-based electronic form used to submit reportable events to the Department of Health:
  - Formerly known as Hippocrates
  - Informs Acute Care Survey and Certification Only
  - Does not replace any other reporting requirements

# Healthcare Professional Responsibility and Reporting Enhancement Act

The Health Care Facility Inquiry Regarding Health Care Professional or CN-9 is available on the NJ DOH website.

Maintain records of occurrence that triggered the creation of the report to the Clearinghouse

CMPs may be issued for failing to report, retain records, cooperate with a request for information





# Healthcare Professional Responsibility and Reporting Enhancement Act

All healthcare entities must be in compliance with 8:30 Health care entities shall:

Notify the Clearinghouse Coordinator

Use the required form to notify the Coordinator

Cooperate with requests for information by the Division, a board, or the Medical Review Panel

Execute a joint report to the Coordinator with a healthcare professional
